CCS RULES & RESPONSIBILITIES STUDENT VEHICLES

- No student shall be permitted to drive any car or motorcycle on the school grounds without a valid driver's license.
- Vehicles must be licensed and insured. The school is not responsible for the vehicle or its contents.
- All vehicles must be registered with the CCS Vehicle Registration Form located in the school office. The Vehicle Registration Form must be completed and turned in to the office prior to parking a car on campus during the day. Students must provide the office with proof of insurance and registration.
- Sitting in a parked vehicle before, during, or after school is not permitted.
- Students are not to park in other parking areas during the school day without permission from a teacher or the administration.
- Student vehicles are subject to search if there are reasonable grounds to believe that drugs, alcohol, stolen property, or other contraband might be present in the vehicle.
- CCS students are not allowed to drive other students' vehicles.
- No student may ride in another student's car without written permission from the parents of the passenger and driver.
- Students may not drive on field trips or other schools related events scheduled during the student's school day, unless prior permission from parents and administration is given.
- Students will sign out in the school office when they need to leave campus for any reason, and sign back in when they return.
- Juniors and seniors may leave campus to attend dual-enrollment courses at GCSC.
- Seniors may leave campus to eat lunch but must sign out and sign back in upon return. Students may not bring back food for other students without prior permission from the appropriate teacher.
